IN ORDER TO UNDERSTAND THE COMPLEXITY AND LIMITATIONS OF THE EU FRAMEWORK UNDER THE EUROPEAN NEIGHBOURHOOD POLICY (ENP) AND THE EASTERN PARTNERSHIP INITIATIVE (EAP) – THAT IS, TO CONSIDER THE INTERFACE BETWEEN POLICY INSTRUMENTS, INSTITUTIONAL STRUCTURES, AND MULTIPLE AGENTS – ONE NEEDS TO ADOPT AN ORIGINAL ANALYTICAL PERSPECTIVE OF PRACTICES TO COMPREHENSIVELY ASSESS THE POLICIES’ OUTCOMES.
